Kristjan Hiiemaa

Kristjan Hiiemaa developed his first software when he was 14 and then sold it, and his first computer, to a shop in his local village, to buy a more powerful computer. In 2009, he founded the international cash and warehouse software company Erply, whose headquarters are in New York and whose services are currently used by more than 100,000 companies, with accounts such as Elizabeth Arden and Athletes Foot, among others. Erply ranks among Europe's ten most promising start-ups, tech gurus suggesting we should kept an eye on the company's developments. TechCrunch, an influential technology blog, has called Erply the Skype of business software. For Erply, the spring board was the winning of the Seedcamp business ideas competition in London in the year of its foundation. This brought prominent investors on board. Hiiemaa believes that they were able to win because of their courage to think bigger than the competition. Hiiemaa has learned many lessons from Erply's rapid rise on the global market, especially when it comes to the hiring of the best specialists on both sides of the ocean.



Marek Helm

General Director of the Tax and Customs Board

During the period 2006–2007, while working at the Ministry of Interior Affairs, Marek was a part of the project team for the internal security area, which prepared Estonia's accession to the Schengen judicial area. Estonia met the requirements of the European Commission with flying colours and joined the Schengen judicial area on 21 December 2007. Beginning in September 2007, Marek was responsible for setting up the Police and Border Guard Board within the area of government of the Ministry of Social Affairs. The project included, among other things, introduction of the business software SAP in the joint internal security agency to support the management of finances, personnel and logistics. In connection with the Police and Border Guard Act, approved by the Riigikogu on 6 May 2009, and the Act Amending the Government of the Republic Act, a legislative basis has been created to harmonise the organisation of management and significantly more substantial cooperation between the areas of law and order, criminal police, border guarding, citizenship and migration supervision, but also in the supporting areas – personnel, logistics and financial management – of the agency to be founded. Beginning in November 2009, as the deputy secretary general for administrative policy matters, Marek was responsible for the organisation of the work of public services, state procurement and state aid, policy-shaping related to state-owned real property, national accounting and the treasury. Since 2011, Marek Helm has been the general director of the Tax and Customs Board.
